HOLLYWOOD CASINO TOLEDO MYCHOICE. MYSUMMER. RULES AND REGULATIONS

Promotional Period:

- 1. The promotional period shall begin on Monday, July 1, 2019 at 5:00AM and end on Thursday, August 29, 2019 at 8:00PM.
- 2. Drawings will be held every Thursday in July and August from 2:00PM-8:00PM.
- 3. On Thursday, July 18 prizes will be shared with the mychoice. mysummer. Launch Party.

Eligibility:

- 1. Open to Marquee Rewards or mychoice members.
- 2. Must be 21 years of age or older to obtain a mychoice card.
- 3. No purchase necessary to receive a mychoice card.
- 4. Participants will receive one (1) free entry during the promotional period by inserting their Marquee Rewards or mychoice card into any slot machine reader. Once the slot machine reader registers the participant's name they will need to remove their Marquee Rewards or mychoice card or begin playing.
- 5. For every one (1) tier point earned during the promotional period, participants will earn five (5) additional entries into the drawings.
- 6. It is the responsibility of the participant to ensure they have their card properly inserted into a slot machine to track their tier points.
- 7. Entries are applied to player's mychoice account based on the date and time their player's card is removed from the slot machine.
- Entries must be activated within thirty (30) minutes of each drawing time by inserting their Marquee Rewards or mychoice card into any slot machine reader with at least one (1) minimum bet or swiping at any kiosk.
- 9. A participant must ask to be rated at a table game to earn tier points.

Implementation:

- 1. On the drawing dates listed above, one (1) guest will be electronically selected every thirty (30) minutes.

- 4. Once the guest is in the money machine, they will have thirty (30) seconds to collect as many bills as possible.
- 5. As the guest is collecting the bills, they will have to transfer the bills into the black box attached to the front of the money machine.
- 6. After the thirty (30) seconds are finished, the guest will immediately stop collecting bills and will be helped out of the money machine.
- 7. The black box will be detached and only the bills in the black box will count towards the guest's prize.
- 8. A marketing representative will then count the guest's bills in the black box to reveal what they have won.
- The amount the guest collected in the money machine will be rounded up to the nearest multiple of ten (10) then doubled for the final amount that the guest will receive in FREE SLOTPLAY/FREE BET.
- 10. If a guest is called and cannot or does not want to participate in the promotion, a consolation prize of one hundred dollars (\$100) FREE SLOTPLAY/FREE BET will be offered.

- 15. If the winner that receives the St Kitts package declines the offer, a consolation prize of two thousand five hundred dollars (\$2,500) FREE SLOTPLAY/FREE BET will be offered.
- 16. If the winner that receives the property of choice trip declines the offer, a consolation prize of one thousand two hundred fifty dollars (\$1,250) FREE SLOTPLAY/FREE BET will be offered.
- 17. If a guest retrieves more than one (1) trip then the guest will have the choice of the trips they retrieved from the money machine that they would like to accept.
- 18. Drawings will be announced over the internal PA system and displayed on the promotion TVs located around the casino floor. It is the responsibility of the participant to hear their name being called.
- 19. Participants will have five (5) minutes to report to the Promotions Area between High Limit and the Poker Room to claim their prize.
- 20. If the winner does not claim their prize in the allotted time another name will be drawn. This will continue until we have a winner.
- 21. Time limits will be strictly enforced.
